i) Application PA24/05788 Proposal Non-material amendment to decision PA22/02647 dated 11.05.2022 to change the single door to a window on northwest elevation of garage. Location Solmer Sea Meads Praa Sands Penzance Cornwall TR20 9TA

A time extension was not permitted for this application. This is confirmation of the decision made at the meeting of 6 August 2024: Breage Parish Council supports the application. Confirmed.

**ii)** Application PA24/05885 Proposal Non-material amendment in relation to decision notice PA22/08722 dated 27.10.22 for new flat roof to porch and replace all existing and new consented timber windows with new uPVC windows to match the approved windows in every other respect. Location Trewell Cottage Drunkards Lane Trew Breage Helston Cornwall

## b) TO CONFIRM BREAGE PARISH COUNCIL'S PLANNING DECISIONS

i) Application PA24/04270 Proposal Erection of a dwelling with new vehicular driveway Location Westward Ho Main Road Ashton Helston

Breage Parish Council supported the application but only with the condition that the entrance/egress is moved either to the actual Westward Ho property entrance/egress or through the gate into the field where the Highways stated visibility splays could be met, stating that, it should not be situated on the blind bend.

However, the Officer wished to approve the application and requested BPC 1. To agree with their recommendation; 2. To agree to disagree or 3. Having made strong planning reasons: To maintain BPC's original position on the proposal against the Officer's recommendation, requesting that the application is determined by the Planning Committee. Of the voting Councillors, 3 Councillors replied: TW, DT and MS, all choosing option 3. This was relayed to the Officer.

**This was confirmed.** The Chairman noted that only 3 Councillors had responded and asked that in future Councillors took care to respond to Planning Officers' further requests.
